#### 1.1 About ADEE

The Association for Dental Education in Europe (ADEE) was founded in 1975 as an independent European organisation representing academic dentistry and the community of dental educators. Since then, ADEE has played an important role by enhancing the quality of education, advancing the professional development of dental educators and supporting research in education and training of oral health personnel.

ADEE brings together a broad-based membership across Europe comprised of dental schools, specialist societies and national associations concerned with dental education.

#### 1.2 Mission statements

ADEE is committed to the advancement of the highest level of health care for all people of Europe through its mission statements.

- To promote the advancement and foster convergence towards high standards of dental education
- To promote and help to co-ordinate peer review and quality assurance in dental education and training
- To promote the development of assessment and examination methods

#### 1.3 Governance

#### 1.3.1 ADEE Executive Committee

The ADEE Executive Committee is elected by the General Assembly of members to govern ADEE activities. The Executive is the main administrative body of ADEE and ensures the principles of the Constitution of the Association 1996 (revised November 2004 and August 2016) and the Bylaws of the Association 1996 (revised September 2004 and August 2016) are upheld at all times.

The Executive is charged with the responsibility of directing and organising ADEE activities, enacting the decisions of the General Assembly and the monitoring of finances. The Executive has the power to appoint executive and administrative officers to serve in administrative functions of the committee.



In addition to the above a considerable amount of meetings of sub groups of the Executive providing oversight to the COVID 19 Response, Annual Meeting Contingency Planning and alteration, O-Health Edu Erasmus + project work and operational planning. Following the arrival of the COVID19 Pandemic all communication and meetings switched to solely online formats.



#### 1.3.7 Governance Activity During 2021

The Executive Committee as the body within the Association charged with oversight and management of the activities of ADEE and as such performed a number of specific functions during 2021.

#### A: Annual Audit

The ADEE financial year ends 31st December. Books of accounts as maintained by the Dublin office were prepared for presentation to the Associations auditors Meagher Moynihan in early January 2022. A full audit of accounts was performed during late January, early February and a meeting held with the Auditors, ADEE Treasurer and ADEE staff on February 2022, this was facilitated using Zoom Video Conferencing. Initial draft accounts for 2021 were reviewed at this meeting prior to presentation to the scheduled meeting of the Executive in March 2021 for approval and signing.

#### **B:** EU Transparency Register

The Association's registration with the EU transparency register was updated on 2<sup>nd</sup> February 2021. ADEE's registration number is 224420913440-79. The registration must be updated annually. Information on the purpose and role of the Transparency register, associated code of conduct and ADEE's record on the register can be reviewed here.

#### C: Irish Charities Regulatory Return

The Association's registration with the Charities Regulatory Authority in Ireland was updated 19<sup>th</sup> October 2021 following the approval of the 2020 Annual Report and Financial Statements by the General Assembly online. This is within the legislative timeframe allowed. ADEE's registered charity number is 20058111. The full entry including annual reports and financial statements can be viewed by the public at https://www.charitiesregulatoryauthority.ie/ or on the ADEE.org webpage under publications.

Work is ongoing on ensuring ADEE complies with the new ADEE governance Code that came into effect in 2020. This entails considerable work on documentation of ADEE policies and protocols as well as annual reporting mechanisms. The work was begun during 2020 by the ADEE office with the support of Prof Petra Hahn the then ADEE Treasurer and continued in 2021 under the support of Prof Julia Davies ADEE Treasurer and Trustee. Following approval of Trusteeships and the change in constitution at the general assembly the relevant filing were made and approve by the Charities Regulator in October/November 2021.

#### **D: Trustees**

ADEE appointed trustees for a three-year period commencing 1st January 2021, the majority of whom must be resident in Ireland, which is a regulatory stipulation. The current trustees are:

#### E: Bank account signatories

So as to ensure transparency and accountability of ADEE expenditure, amounts in excess of €10,000 require the signature of the Secretary General or Treasurer along with one ADEE staff member. During 2021 the account signatories remained unchanged as follows:

Similar to the majority of organisations, Electronic Funds transfer is replacing the majority of payments. Due to the exit from the Irish Banking market, ADEE is currently in moving its business to another registered Irish Bank and this process will complete in 2022.

#### F: ADEE Staff review

In line with employee contracts, the ADEE staff are reviewed annually in December. The executive acknowledged the additional work taken on by Judith and Denis as ADEE grows and strategic priorities changed in response to COVID and the changes in working patterns this involved.

#### **G: Consitution Update**

The ADEE General Assembly approved an update to the ADEE constitution to enable a new regional structure from 2022. This is the culmination of work commenced in 2019 and has received Charity Regulator approval.

#### 1.4 Continued COVID-19, impact and response

With the arrival of COVID19 in Europe and the declaration of a pandemic in March 2020, ADEE like all organisations faced considerable challenges needing urgent response in a constantly changing operational environment. In line with Irish government policy the ADEE office (being a non-front line service) was closed on 14<sup>th</sup> March 2020 and moved to a home working model. ADEE staff have continued to do so for the entire of 2021. Every effort has been made to ensure the continuity of ADEE business and staff accommodated flexible working hours to facilitated Executive and our member's increasingly complex schedules.

A decision was taken in early 2021 to migrate the Annual meeting to an online platform. While this was most disappointing for our members and of course our committed colleagues in Strasbourg, it was a decision taken in the best interests of public health and safety and so as to ensure a defined meeting offering could be planned and delivered.

During 2021 ADEE Executive related travel did not occur with the exception of an O-Health-Edu Erasmus project meeting in Paris in late November.

The 2021 General Assembly was again delivered via an online platform and the Executive has decided that this will be the case going forward.

Growing on 2020 investments in technologies ADEE invested further in its web resources and supports including considerable front end and back end adjustments being made to adee.org to facilitate online meeting integration and other logistical issues.



## 2.1 2021 Membership data

The Executive continues to work with members to ensure the benefits of membership outweigh the cost. In 2021 the annual membership fee of €575 per institution (which allows all staff and students within the faculty to create a profile and thereby attain access to the EJDE and also discounted ADEE meeting attendance) remains unchanged. Revenue from membership income and corporate partnerships remains ADEE core sources of income.




Figure 1-1 Comparative of Institutional and corporate membership 2019 to 2021

#### 3.1.3 Note on annual finances

The audited annual accounts show a surplus (profit) of 26,864 for the year ending 31.12.21, compared to a deficit (loss) of 22,858 for year ending 31.12.20. Combined this means ADEE has managed to continue business without drawing down on it deposit accounts during the main period of the COVID pandemic. The Executive feels that this outturn is very



positive given the challenging and complex operating environment resulting from COVID and a clear demonstration of how effectively the finances are managed.

Expenditure is now operating at an absolute minimum. It is noted by the Executive the impact membership fees and corporate membership payments have had in attaining this outturn. The absence of an annual meeting is dramatically influencing turnover and in turn the ability to attract corporate support and thus impacted the bottom line directly.

A number of non-standard items are worth nothing as follows with regards finances:

- 1. Income is dramatically impacted by the absence of an annual scientific meeting, annually this tends to generate circa €130,00 turnover and in the region of €10,000 to €30,000 surplus
- 2. Corporate memberships continue to reduced due to COVID as many who availed of gold membership as a means of attaining reduced exhibition fees at the annual meeting have not been present since 2019
- 3. The O-Health-Edu Erasmus + project had a very positive impact on the years finances and greatly enabled the continuity of operations
- 4. Web costs are now stabilising however there will be a need for a review in 2022 so as to enable a more blended meeting if that is what member require and this may require additional resources to deliver
- 5. All other costs were either maintained at a minimal level or reduced

#### 3.2 ADEE Annual Meeting 2021: Strasbourg, France (Online)

#### 3.2.1 Local Organising Committee (LOC)

The Annual Scientific Meeting ADEE 2020 was planned for Strasbourg, France and to be hosted by University of Strasbourg, Faculty of Dentistry. Sadly, the executive had to take a decision in late May to postpone the event until 2021. This was of course a disappointment to the Local Organising Committee and all involved in the considerable preparation to date, however in the interest of public health, there was no choice available. As 2021 evolved it became obvious that COVID would still be an issue and thus it was decided to deliver the 2021 completely online.

The Executive Committee and ADEE office sincerely thank Prof Agnes Bloch Zupan and Prof Olivier Huck and all the team in Strasbourg for their commitment, patience and understanding. Their willingness and support enabled us to delivery a meeting in 2021 that was welcomed by membership and one the Executive view as a very positive experience.







## 4.0 Report on Collaborative Activities

#### 4.1 O-Health-Edu Erasmus + Project

Work on the EU Erasmus + project entitled O-HEALTH EDU "Advancing Oral Health A vision for dental Education" which was granted funding within the KA2 – "Cooperation for Innovation and the Exchange of Good Practices" and KA203 – "Strategic Partnerships for higher education" programs continued in 2021.

This project commenced in October 2019 and spans 3 years with an expected conclusion in August 2022. It is coordinated by the University Clermont Auvergne (France) with the Association for Dental Education in Europe (ADEE) and 8 other university partners. The main objective of this project is to gain a validated and research grounded understanding of the realities of dental education within the EU territory. The project is driven by three overarching objectives. The first is to provide a diagnosis of the current situation of dental education in Europe. The second is to enable a shared understanding and a common vision for the future of Oral Health Professionals' Education among all European stakeholders and policy makers. The last specific objective is to define priorities for a strategic vision and support changes for oral health professionals' education in 2030.

ADEE's role is as the project's dissemination partner. For further information or a more detailed discussion on the project and its aims, please contact the project coordinator and president of ADEE, Prof. Stéphanie Tubert (Stephanie.tubert@uca.fr).

During 2021 ADEE members were invited to participate in the data collection element of the project. Presentations were made to FEDCAR, The IADR annual conference and a number of other stakeholders to encourage participation and to share the evolving outcomes.

In late 2021 the O-Health-Edu data hub went live in it is initial form and continues to evolve to the project needs since. #### 4.3 American Dental Education Association (ADEA)

Members of the ADEE Executive and Office attended the online ADEA meeting during March 2021. It was decided that the planned hosting Shaping the Future of Dental Education VI in 2023 in Belgium would not now go ahead due to the concerns over the impact of the Pandemic.

During 2020 ADEE availed of 'observer membership' of European Alliance of Subject-Specific and Professional Accreditation & Quality Assurance (EASPA). The executive will continue to monitor and report on this new alliance and its relevance to oral health professions. Membership was renewed for 2021.

Participation in Spark review of the Annex V PQD

Prof Ilze Akota ADEE President and Prof Cristina Manzanares ADEE EU officer were invited to participate and present to a working group facilitated by Spark Legal network on behalf of the European commission focused on the review of the annex V of the professional qualifications directive. In advance of this ADEE facilitate a number of briefing session for members and these can be viewed here.

While the ADEE emphasised the need for a seismic and the inclusion of a competence approach the commission have made it clear that all that could be facilitated was an updating of the subjects list. Once the final report issues from the Commission it will be circulated to ADEE membership for information, and ADEE will continue to act on behalf of its members to strive for the most up to date curriculum and approach to dental education in the coming decades.

## 7.0 Advancing ADEE's Charitable Purpose

ADEE is founded with a core charitable purpose of the advancement of dental education through the promotion of excellent and the fostering of convergence through collaboration. While all ADEE activity is grounded in this principle during 2020 two key aspects are emphasised:

#### 7.1 ADEE scholarship

2018 saw the introduction of a new Scholarship stream delivered in partnership with GSK, namely the Advancement of Dentistry in Society Scholarship Award. The aim of the scholarship was to acknowledge and encourage ADEE members (Dental Institutions, Universities and Associations) to document and share aspects of their curriculum that demonstrate excellence in how they:

- incorporate public dental health elements within their curriculum
- encourage students to appreciate aspects such as local and regional health needs, their variations and implications of health economics
- encourage a whole health approach within their curriculum including but not limited to encouraging inter professional care
- include local population needs within their curriculum and encourage students to take a holistic approach to defining and delivering patient care
- ensure health promotion (oral and whole health) is not only encouraged but facilitated through the curriculum and how such activities within the curriculum is impacting on local populations
- encourage an ethos of equity of access within their students practice
- integrate wider oral and public health issues within their curriculum



Following evaluation of 2021 applications, a single award of €5,000 was made to:

**Cork University Dental School & Hospital** Cork, Republic of Ireland: was recognised for their project focusing on creating and developing a knowledge clip repository focusing on Dental Public Health, Epidemiology, Health Inequalities, Health Promotion, Care in the Community etc. The clips will be integrated into teaching and learning strategies in a number of Oral Health Professional's programmes to

enhance student understanding of the Dentistry in Society concept.

As part of the award the recipient are expected to make presentations of their work at an upcoming ADEE meeting.



To enable this a dedicated section of the ADEE website was created and curated by members of the Executive for the first six months of the pandemic. The section continues to be updated and the section has remained open access to all





#### 8.0 Communications

During late 2020 adee.org was considerable evolved, with additional components and online resources added. As members will be aware the migration from our old site led to Data protection concerns and thus users were required to create new accounts on the new server. It is national that this would result in a decrease in user profiles and subscribers. However we are now confident that the database of users is current and active. By late December the registered users on the site amounted to 670 persons while those who have signed up to the regular news updates from ADEE amount to 1300 plus.

During 2021 ADEE.org increase it's web traffic - over 71.811 unique visits the website and total of over 108.360 visits and a staggering 2.615,926 hits. May, June and July were the busiest months online while January had the least online traffic.

Within the week days ADEE.org usually hits it's peak traffic during Thursdays and Fridays.
