## 1.1 About ADEE

The Association for Dental Education in Europe (ADEE) was founded in 1975 as an independent European organisation representing academic dentistry and the community of dental educators. Since then, ADEE has played an important role by enhancing the quality of education, advancing the professional development of dental educators and supporting research in education and training of oral health personnel.

ADEE brings together a broad-based membership across Europe comprised of dental schools, specialist societies and national associations concerned with dental education.

## 1.2 Mission statements

ADEE is committed to the advancement of the highest level of health care for all people of Europe through its mission statements.

- To promote the advancement and foster convergence towards high standards of dental education
- To promote and help to co-ordinate peer review and quality assurance in dental education and training
- To promote the development of assessment and examination methods

- To disseminate knowledge and understanding on education
- To provide a European link with other bodies concerned with education, particularly dental education.

## 1.3 Governance

### 1.3.1 ADEE Executive Committee

The ADEE Executive Committee is elected by the General Assembly of members to govern ADEE activities. The Executive is the main administrative body of ADEE and ensures the principles of the Constitution of the Association 1996 (revised November 2004 and August 2016) and the Bylaws of the Association 1996 (revised September 2004 and August 2016) are upheld at all times.

The Executive holds the responsibility of directing and organising ADEE activities, enacting the decisions of the General Assembly and the monitoring of the association's finances. The Executive has the power to appoint executive and administrative officers to serve in administrative functions of the committee.

During 2022 the ADEE created a new advisory group to the ADEE Executive Committee, the ADEE Regional Council. The Council brings together representatives from the ADEE regions to consult and advise the Executive on its work.

The ADEE Executive Committee is in post for the period 1<sup>st</sup> January to 31<sup>st</sup> December of a given year. During 2022 the Executive Committee and regional councils were constituted by the following:

In addition to the above sub groups of the Executive attended meetings providing oversight to the COVID 19 Response, Annual Meeting Contingency Planning and alteration, O-Health Edu Erasmus + project work and operational planning.

### 1.3.7 Governance Activity During 2022

The Executive Committee as the body within the Association charged with oversight and management of the activities of ADEE and as such performed a number of specific functions during 2022.

#### A: Annual Audit

The ADEE financial year ends 31<sup>st</sup> December. Books of accounts as maintained by the Dublin office were prepared for presentation to the Associations auditors Meagher Moynihan in early January 2023. A full audit of accounts was performed during late January, early February and a meeting held with the Auditors, ADEE Treasurer and ADEE staff on February 2023, this was facilitated using Zoom Video Conferencing. Initial draft accounts for 2022 were reviewed at this meeting prior to presentation to the scheduled meeting of the Executive in March 2023 for approval and signing.

#### B: EU Transparency Register

The Association's registration with the EU transparency register was updated on 17<sup>th</sup> January 2022. ADEE's registration number is 224420913440-79. The registration must be updated annually. Information on the purpose and role of the Transparency register, associated code of conduct and ADEE's record on the register can be reviewed here.

#### C: Irish Charities Regulatory Return

The Association's registration with the Charities Regulatory Authority in Ireland was updated 18<sup>th</sup> October 2022 following the approval of the 2021 Annual Report and Financial Statements by the General Assembly online. This is within the legislative timeframe allowed. ADEE's registered charity number is 20058111. The full entry including annual reports and financial statements can be viewed by the public at <https://www.charitiesregulatoryauthority.ie/> or on the ADEE.org webpage under publications.

Work is ongoing on ensuring ADEE complies with the new ADEE governance Code that came into effect in 2020. This entails considerable work on documentation of ADEE policies and protocols as well as annual reporting mechanisms. The work was begun during 2020 by the ADEE office with the support of Prof Petra Hahn the then ADEE Treasurer and continued in 2021 under the support of Prof Julia Davies ADEE Treasurer and Trustee. Following approval of Trusteeships and the change in constitution at the general assembly the relevant filing were made and approve by the Charities Regulator in October/November 2022.

#### D: Trustees

ADEE appointed trustees for 1<sup>st</sup> January 2021 – 31<sup>st</sup> December 2024 are detailed below. In line with legislation the majority of whom must be resident in Ireland. The current trustees are:

**E: Bank account signatories**

During 2022 ADEE migrated its bank accounts from KBC and Ulster Bank due to their leaving of the Irish Market. ADEE new Bank account is with AIB. This has resulted in a change in banking process all of which are now fully electronic and cashless:

**F: ADEE Staff review**

In line with employee contracts, the ADEE staff are reviewed annually in December. The executive acknowledged the additional work taken on by Judith and Denis as ADEE grows and strategic priorities changed in response to COVID and the changes in working patterns this involved

**G: Constitution Update**

The 2021 ADEE General Assembly approved an update to the ADEE constitution to enable a new regional structure from 2022. This is the culmination of work commenced in 2019 and has received Charity Regulator approval. The first regional council was constituted in late 2022 following an open call for membership by region.

**1.4 Continued COVID-19, impact and response**

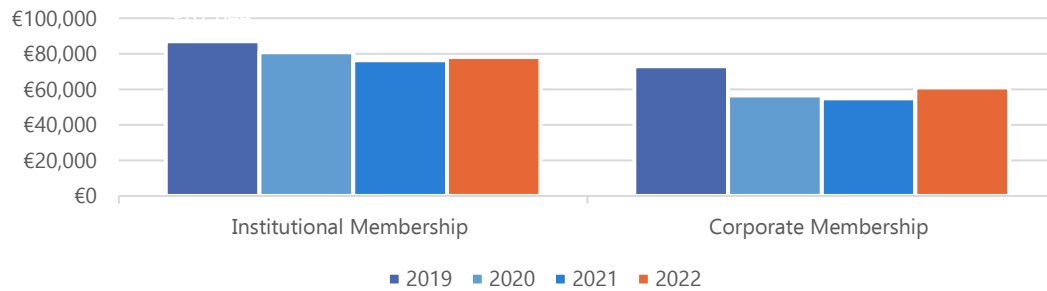
The impact of COVID 19 continued well into 2022 and caused a considerable amount of uncertainty around annual meeting planning and other operational logistics. ADEE is pleased to advise that despite this a face to face meeting was delivered in 2022.

During 2022 ADEE continued to add to its online resources for educators around COVID and the majority of operational business was delivered either hybrid or fully electronic.

## 2.1 2022 Membership data

The Executive continues to work with members to ensure the benefits of membership outweigh the cost. In 2022 the annual membership fee of €575 per institution (which allows all staff and students within the faculty to create a profile and thereby attain access to the EJDE and also discounted ADEE meeting attendance) remains unchanged. Revenue from membership income and corporate partnerships remains ADEE core sources of income so as to fund the office functions.

As can be seen from figure 2.1 the absence of a face-to-face meeting had an impact on both our corporate and institutional membership in 2020 and 2021. However, thanks to the ongoing support of core membership and corporate partners this impact was kept to a minimum. The executive committee sincerely thanks the members who paid annual membership during the uncertainty of 2020 and 2021. Thankfully with the return to a face-to-face presentation in 2022 memberships have again begun to rise slowly. The Executive and membership are sincerely grateful for the continued support from corporate partners who continued their membership throughout the COVID pandemic and in particular those who embraced the online meeting format for delivery of sessions and content. The return of the ADEE Exhibition in 2022 was greatly welcomed by the Executive and corporate partners alike.

### 3.1.3 Note on annual finances

The audited annual accounts show a deficit (loss) of 59,199 for the year ending 31.12.22, compared to a surplus (profit) of 26,864 for year ending 31.12.21. Like many similar organisations the return to in person environments while still navigating an uncertainty around the next evolution of the COVID pandemic in 2022 led to challenges on a number of fronts. Given the variety of regulations in place in different regions, travel became more complex and costly. In addition venue hire, accommodation costs and even catering all have seen dramatic cost increase over 2022 and it is expected these will continue into 2023.

While normal operational expenditure such as office and admin costs are operating at an absolute minimum, other costs have soared in a post COVID era.

A number of items are worth nothing as follows with regards the finances detailed above:

1. With the return to an 'in person' conference annual income is on the rise and heading again towards pre COVID level, for reference in 2019 the annual income was €520,000.
2. The post COVID era has seen a dramatic increase in meeting cost. For example, delivery of the annual meeting in Berlin in 2019 cost €166,643 while delivery of Palma with approximately 25% less attendance cost €202,202 as can be noted from the above accounts extract.
3. The Executive are pleased to see institutional and corporate memberships grow and hope that those members who discontinued membership during COVID will return to the ADEE in due course.
4. Executive related costs return to a pre COVID level with the return also to face to face executive meetings and site visits for future meetings during late 2022. The same is true for international and EU engagements which too say a return to some face to face events.
5. Staff salaries have remained unchained during COVID and it should be noted that the CAO contract is due for renewal during 2023.
6. It is hoped that LEADER will also return to being an income stream during 2023.

### 3.2.1 Local Organising Committee (LOC)

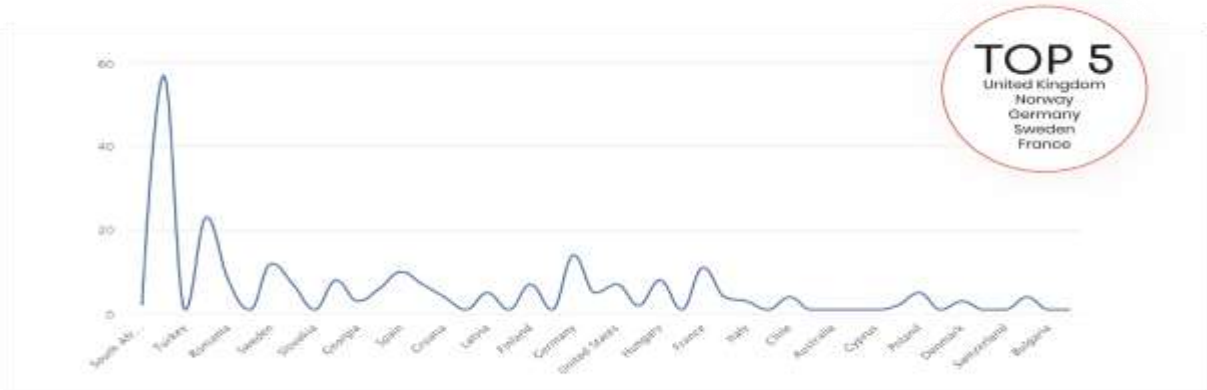

## 4.0 Report on Collaborative Activities

### 4.1 O-Health-Edu Erasmus + Project

Work on the EU Erasmus + project entitled O-HEALTH EDU “Advancing Oral Health A vision for dental Education” which was granted funding within the KA2 – “Cooperation for Innovation and the Exchange of Good Practices” and KA203 – “Strategic Partnerships for higher education” concluded its work in 2022.

This project commenced in October 2019 and spans 3 years with presentation to membership at ADEE 2022 in August 2022. It was coordinated by the University Clermont Auvergne (France) with the Association for Dental Education in Europe (ADEE) and 8 other university partners. The objective of this project was to gain a validated and research grounded understanding of the realities of dental education within the EU territory. The project was driven by a number of overarching objectives including;

- diagnosis of the current situation of dental education in Europe
- to enable a shared understanding and a common vision for the future of Oral Health Professionals' Education
- to define priorities for a strategic vision and support changes for oral health professionals' education in 2030.

During 2022, the project's webpage collected and displayed data from over 70 schools and it continues to grow. A number of publications have issued and some key publications are in train for publication in 2023 and these will be available free to ADEE members via the European Journal of Dental Education.

Final payments for the project were approved in late 2022. ADEE Executive committee wished to sincerely thanks Prof Tubert Jeannin.

### 4.2 Collaborative stakeholder groups

During 2022 ADEE continued to reach out and engage with relevant stakeholder groups at a European level. These included but are not limited to the Council of European Dentists, The Platform for Better Oral Health in Europe, the European Dental Students Association, the Federation of European Dental Competent Authorities and Regulators and many other societies. All communication and collaboration during 2022 was transacted online.

#### 4.2.1 American Dental Education Association (ADEA)

ADEE Secretary General Prof Barry Quinn and Chair of the Board of IFDEA Prof Corrado Paganelli represented ADEE in person at the ADEA annual meeting during March 2022. The ADEE Executive were pleased to welcome a strong delegation from ADEA to our meeting in Palma. Forging strong collaboration with international sister organisations is not only key to ADEE's future but also brings considerable value to ADEE core membership, through collaborative transatlantic activities, sharing of best practices and research.

#### 4.2.2 ENQA

ADEE remains as an associate member of ENQA in 2022. The Executive will review this relationship in 2023 to ensure it provides value for return on investment.

#### **4.2.3 EASPA**

‘Observer membership’ of the European Alliance of Subject-Specific and Professional Accreditation & Quality Assurance (EASPA) was renewed for 2022.

#### **4.2.4 EDSA**

Despite being now based in Amsterdam, the ADEE office continued to assist and support EDSA in whatever way was possible during 2022. This included a shared social event as part of ADEE 2022 Palma, guidance to the EDSA treasurer on the Irish Charity sector etc.

#### **4.2.5 South American Associations**

Prof Cristina Manzanares continues to represent ADEE at the various dental education associations in South America where there is grown interest in European Collaboration and in the O-Health-Edu project.

## 5.0 Report on European Journal of Dental Education (EJDE)

Dr Ronald Gorter presented his annual report to the assembly and also chaired a face to face meeting of the editor board while at the Palma Meeting. It should be noted that the publisher reports on the activity to the end of December of the previous year this the following refers to year end Dec 2021 activity.

During his presentations Dr Gorter highlighted the following;

- The European Journal of Dental Education is published in collaboration between ADEE and Wiley. The journal was started in 1997 and is now in vol. 29. Its impact fact recorded for 2021 is 2.528.
- The Journal is ranked 57/92 in the field of Dentistry, Oral Surgery & Medicine and 23/44 Education, Scientific Disciplines.
- The accept rate was 18.2% in 2021, a decrease from 20.9% in 2020. This compares with an accept rate of 20.1% across all Wiley journals in the Dentistry subject area.
- The total number of submissions in 2021 decreased (-16.3%) compared with 2020. This compares with a decrease (-10.7%) across all Wiley journals in the Dentistry subject area.
- In EJDE 36% of articles are published Open Access in 2022

Of note is that an article from the EDJE is the 4<sup>th</sup> most downloaded article in 2021 on Wiley. See figure 4.1.

## 7.0 Advancing ADEE's Charitable Purpose

ADEE is founded with a core charitable purpose of the advancement of dental education through the promotion of excellent and the fostering of convergence through collaboration.

### 7.1 ADEE scholarship

2022 saw a continuation of the partnership with GSK, namely the Preventative Dentistry in Society Award. The aim of the award is to acknowledge and encourage ADEE members (Dental Institutions, Universities and Associations) to document and share aspects of their curriculum that demonstrate excellence in how they:

- incorporate public dental health elements within their curriculum
- encourage students to appreciate aspects such as local and regional health needs, their variations and implications of health economics
- encourage a whole health approach within their curriculum including but not limited to encouraging inter professional care
- include local population needs within their curriculum and encourage students to take a holistic approach to defining and delivering patient care
- ensure health promotion (oral and whole health) is not only encouraged but facilitated through the curriculum and how such activities within the curriculum is impacting on local populations
- encourage an ethos of equity of access within their students practice
- integrate wider oral and public health issues within their curriculum

Following evaluation of 2022 applications, two awards of €2,500 each were made to:

ADEMA University School, Spain in recognition for their oral healthcare in the community project and for their volunteer Africa project both aims at embedding a sense of community responsibility with in their graduates.

The University of Liverpool School of Dentistry, UK in recognition for their project "The Liverpool Tooth Buds", that aims to increase Oral and general health promotion for underprivileged children and asylum seekers in Liverpool and North-West England.

## 7.2 COVID 19 information and resources

Early in the COVID Pandemic the Executive stressed the need to share reliable and impartial information from multiple sources so faculty and students could inform themselves on the evolving situation. To enable this a dedicated section of the ADEE website was created and curated by members of the Executive for the first six months of the pandemic. The section continued to be updated and the section has remained open access to all during 2022.
